### ***General***

1. Every application for the renewal of licence should solely be made on this application form.
2. All sections of this application form must be duly completed. Kindly use “N/A” which stands for “not applicable” for any section or sub-section which is not relevant to the application.
3. The application for renewal of licence should be sent to **The Director, Radiation Safety and Nuclear Security Authority, Royal Road, Helvetia, MOKA**. The application may be submitted to the Authority by email on the following address [rsnsa@govmu.org](mailto:rsnsa@govmu.org).

### ***Section 1***

4. The applicant should be the licensee. In this section, the name of the licensee, the Licence Certificate Number and the contact details of the licensee should be provided.

### ***Section 2***

5. In this section, the number of radiation generator(s) and sealed radioactive source(s) at the facility, irrespective of the status of the radiation sources should be provided. Details of all the radiation sources at the facility should be provided as per the attached MS Excel template ‘**Inventory of Radiation Sources**’. The type of radiation source should be selected from the predefined list.

### ***Section 3***

6. In this section, the name, contact details, qualifications and experience of the Radiation Protection Officer (RPO) for the facility, appointed by the licensee under Section 20(1)(c) of the Radiation Safety and Nuclear Security Act 2018 should be provided.

### ***Section 4***

7. A radiation worker is any worker at the facility who is occupationally exposed during the course of his/her work. In this section, the number of radiation worker(s) at the facility should be provided. The list of radiation worker at the facility should be submitted using the MS Excel template ‘**List of Radiation Workers**’ provided.

### ***Section 5***

8. This section should be duly signed by the licensee, or his/her representative, confirming that all information provided in the application form, including all additional information and documents attached thereto, are true, accurate and complete.
