### ***General***

1. Any application for Notification on the use of radiation sources should solely be made on this application form. This application form is available at our office and is also downloadable from our website (<http://rsnsa.govmu.org>).
2. Each section of this application form must be duly completed.
3. The Notification on the use of radiation sources should be sent to:

### ***Section 1***

4. In this section the applicant should provide the name and address of the facility wherein the radiation sources are being stored or used.

### ***Section 2***

5. The Contact Person is the person with whom the RSNSA may liaise for any additional information regarding the notification. In this section, the name, designation and contact information of that person should be provided.

### ***Section 3***

6. In this section, the applicant should provide details of all radiation generator(s) being used at the facility including the RPA registration number if same was already registered to the RPA. Radiation generators are electrical devices producing ionising radiation e.g. x-ray equipment, accelerators, etc.

### ***Section 4***

7. In this section, the applicant should provide details of all radioactive source(s) and their associated equipment being used at the facility including the RPA registration number if same was already registered to the RPA.

### ***Section 5***

8. This section should be duly signed by the person submitting the notification confirming that all information provided in the application form, including all additional information and documents attached thereto, are true, accurate and complete.
